

The ICOMOS Aotearoa New Zealand annual general meeting and conference was held in Ōtepoti Dunedin from Friday 18 to Sunday 20 October 2024. Over three glorious spring days we came together for the AGM and a conference on the theme of 'Everyone's Heritage: Celebrating the values of heritage in Aotearoa New Zealand'.

Heritage New Zealand Pouhere Taonga hosted welcome drinks on Friday at their office in Princes Street. The Minister for Arts, Culture and Heritage, **Hon Paul Goldsmith**, opened the conference on Saturday morning with a speech followed by a lively question and answer session. practitioners of all types, particularly from some amazingly skilled craftspeople, against the backdrop of what is (arguably) our country's most heritage-rich and heritage-friendly city, Ōtepoti Dunedin.

Papers brought some complex issues to the fore, including: how we attract and train a new generation of practitioners, how we make our services accessible, and how we ensure the protection of our heritage in a difficult political, economic, seismic, and meteorological environment. But, more importantly, it reinforced the fact that there are like-minded people out there who share in the challenges and the joys of working with heritage and recognise how important it is.

The conference was also an opportunity to go on some enlightening field trips. These included Larnach Castle, a walk around Otago University and having a peek at works-in-progress at Dunedin Prison.

Resource Management (Consenting and Other System Changes) Amendment Bill

This bill amends the Resource Management Act 1991 to progress Government priorities, including making it easier to consent new infrastructure, encouraging investment in renewable energy, and making medium-density residential standards optional for councils.

ICOMOS Aotearoa New Zealand members may wish to submit on the proposed amendment that affects heritage. This amendment provides for heritage buildings and structures to be listed or delisted using simplified planning processes.

Save the Chateau Tongariro Hotel petition

Ruapehu District Council Mayor **Weston Kirton's** <u>Petition</u> to save the Chateau Tongariro Hotel is still active and seeking signatures.

The future of the Chateau Tongariro Hotel hangs in the balance, with negotiations underway and decisions pending from government officials. There is a strong desire from the local community, as well as from people across New Zealand and around the world, to see this iconic building saved. By imploring the Government to act with urgency to save the Chateau, we seek to preserve a treasured piece of our cultural heritage along with the economic prosperity and tourism excellence that it represents.

The closing date for accepting signatures has been extended to **30 April 2025**.

Heritage New Zealand Pouhere Taonga seeks feedback on Statements of General Policy Review

The Heritage New Zealand Pouhere Taonga Act 2014 requires HNZPT to review its Statements of General Policy at least once every 10 years and a review is now due.

Statements of General Policy guide how legislation – in this case, the Heritage New Zealand Pouhere Taonga Act 2014 – is implemented. HNZPT's Statements of General Policy help HNZPT to make decisions and set the standards of performance you can expect from the organisation.

The review is an opportunity to reflect on experiences using HNZPT's existing Statements of General Policy, and to help update policies.

ICOMOS Aotearoa New Zealand members are encouraged to make submissions.

From the Board

The AGM of ICOMOS Actearoa New Zealand was held on 20 October 2024 at Toitu Settlers Museum, Dunedin. The board met after the AGM.

Annual General Meeting

The Chair's report summarised the range of activities undertaken by the board and national committees throughout 2024, including the ongoing engagement with the Heritage Senior Leaders Forum.

The changing landscape of heritage legislation in Aotearoa New Zealand has been very much at the forefront this year. Discussion and a shared submission were undertaken with the Professional Historians' Association of New Zealand/Aotearoa (PHANZA) on the Fast Track Approvals Bill; ICOMOS Aotearoa New Zealand also appeared before the Environment Select Committee to provide feedback, focusing on the potential impacts on our shared cultural heritage.

One of the highlights from this year has been the refresh of the website, which looks fantastic. If you haven't yet had a chance to have a look, do check it out <u>https://icomos.org.nz/</u>. Huge thanks are due to **Amanda Mulligan** for spearheading the project.

A number of scholarships have been awarded to Emerging Professionals over recent years, with **Alex Vakhrousheva** receiving the ICOMOS Aotearoa New Zealand Travel Scholarship to contribute towards completing her time at the Longford Academy in 2025.

Committees have focused on strategic priorities for this year and beyond, including our contributions to international advisory committees and working groups.

Stacy Vallis was reappointed as President, and board members were elected for 2025.

Suspension of Enrolments into Heritage Conservation Programmes

The University of Auckland Waipapa Taumata Rau is in the process of suspending enrolments into the Master of Heritage Conservation (MHerCons) and the related heritage conservation programmes -MArch(Prof)HerCons, MUrbPlan(Prof)HerCons, and PGCertHerCons – taking effect in 2025. Suspending enrolments is the first step towards the deletion of the the time programmes. At of writina. the recommendation to suspend enrolments still awaited its final approvals, but staff have been acting on the basis that it is effectively a decision. It is disappointing for staff who have taught into the programmes since 2016, believe in the importance of heritage processes and conservation, and have done their best to argue for retention.

The Master of Arts remains on offer for those interested in studying museums and cultural heritage and archaeology. The MA in Museums and Cultural Heritage now also becomes the best option for people wanting to complete more than one of the four 15-point postgraduate seminar courses that the School of Architecture and Planning teaches in built heritage.

The four seminar courses will all be taught in 2025. They are:

HERCONS 700, Heritage Processes. This course examines heritage conservation legislation, policy, guidelines and processes. It includes international context as well as New Zealand laws and processes. In recent years it has been taught by Dr Elizabeth Aitken Rose and also by Nicola Short.

HERCONS 701, Heritage Assessment and Conservation Planning. This course explores the assessment of cultural heritage value and the use and preparation of conservation plans to guide heritage conservation work. Coursework comprises the researching and writing of a conservation plan. I teach this one.

HERCONS 702, Conservation of Materials. This course focuses on the theory and practice of conserving materials commonly found in heritage buildings and

artefacts, including stone, brick, timber, concrete and steel. It is taught by **Dr Phillip Hartley**.

HERCONS 703, Diagnosis and Adaptation. This course investigates existing building fabric, diagnosis of issues impacting upon the state of repair or the level of comfort, and the adaptation of heritage buildings, including strengthening, energy upgrading, reuse and the design of additions and alterations. It is taught by **Robin Byron**.

Olga Pavlenko



Olga is a skilled architectural graduate with a Bachelor of Architecture from Kazakhstan and a Master of Architecture from Unitec in Auckland.

She joined DPA Architects, a renowned heritagefocused practice based in Devonport, in 2021, bringing valuable experience from her previous work in New Zealand, where she contributed to a variety of commercial and residential projects. At DPA, Olga plays a key role in all stages of the architectural process, from initial concept design through to construction observation. She particularly enjoyed overseeing the retrofitting of an early 20th-century villa, guiding the project from concept to completion. During this project, Olga ensured that alterations made to the villa in the 1970s were rectified in a more sympathetic way, preserving the historical integrity of the structure while accommodating modern needs.

Olga's passion for built heritage began during her college studies in Kazakhstan, where she travelled to Western Kazakhstan to work on the conservation of a local ancient necropolis.

Eager to expand her knowledge, she furthered her expertise by completing a specialised online course at the Society for the Protection of Ancient Buildings (SPAB), focusing on the maintenance and repair of historic structures.

Olga is particularly drawn to the integration of historical research with contemporary architecture and advocates for the sustainable preservation and adaptive reuse of heritage buildings, ensuring their longevity.

Tanya Sorrell



Tanya Sorrell is a past member of ICOMOS who has finally gotten around to re-joining. She describes

herself as a historian and policy nerd who loves maps.

She earned a Master's Degree about 20 years ago from the University of California, Riverside in the study of Public History, including a thesis on the student experience at American Indian boarding schools.

Her career has taken many fascinating directions, including as a costumed heritage interpreter, a consultant architectural historian, a nonprofit administrator, manager, and public servant.

Tanya arrived in New Zealand in 2012 and was immediately drawn into the development of Auckland Council's first Unitary Plan. As the excitement of the Unitary Plan died down, Tanya decided to shift to the Ministry for the Environment, where another 'once in a generation' opportunity was taking off with reform of the entire Resource Management system. Alas, we know how that ended, but at least it was massively educational.

In 2024, Tanya moved once again into consulting, working on planning and policy for Mahea, a boutique Māori-owned consultancy focused on work that supports hapū/iwi/Māori to look after their interests and to protect taonga and taiao. Still plenty of heritage to think about in this space.

When not consumed with the world of work, Tanya hangs out with her husband and two sons in her home at Te Hau Kapua in Devonport, cultivating tomatillos on the ruined slope of Takāraro and gazing out at Rangitoto.
